Statement of Reasons

Bush Fair - Harlow

The permanent order is required to keep the junction free of parked vehicles where it is considered that any parking is inappropriate. The order is intended to keep the road free of parked vehicles on a bend where any parking is a hindrance to traffic flow and access. Removing parked vehicles at the junction will also improve safety and reduce the probability of road traffic accidents.

Permanent Orders Section 1(1) of the 1984 Act states that local traffic authorities in England and Wales (outside London)2 may make permanent orders for the following purposes:

- To avoid danger to persons or other traffic using the road or any other road or to prevent the likelihood of any such danger arising;
- To facilitate the passage on the road or any other road of any class of traffic (including pedestrians);
- To preserve or improve the amenities of the area through which the road runs






