Magdalen Green, Colchester

To introduce No Waiting At Any Time from number 9 to 15 Simons Lane/Magdalen Green on its East side

Magdalen Green is a narrow 'dead end' road which has off street parking available to the residents of the road. It has a turning area at the end to allow vehicles to manouvre.

The prevention of parking in this area is required to improve traffic flow and safety for road users particularly larger vehicles and waste collection/emergency service vehicles.

- To avoid danger to persons or other traffic using the road or any other road or to prevent the likelihood of any such danger arising;
- To facilitate the passage on the road or any other road of any class of traffic (including pedestrians);


