

**The Essex County Council (Epping Forest District) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) (Amendment No.51) Order 202x**

**Notice is hereby given** Colchester City Council acting on behalf of the North Essex Parking Partnership in exercise of the delegated powers of the traffic authority Essex County Council granted under an Agreement dated 1<sup>st</sup> July 2022 proposes to make the above Order under Sections 1(1), 2(1) to (3), 4 (1), 4(2), 32, 35,45,46,49 and 53 and Parts III and IV of schedule 9 of the Road Traffic Regulation Act 1984

**The effect of the Order:**

1. To Revoke the No Waiting Mon – Sat 8am to 6.30pm on Farm Hill Road, Waltham Abbey from its junction with Sewardstone road on both sides for approximately 50 metres and along Sewardstone Road on its east side in a southerly direction from Farm Hill Road to meet the Pedestrian crossing markings. Replacing the revoked restrictions with No Waiting at Any Time.
2. To introduce a 23m Bus Stop Clearway cage on the north side of Farm Hill Road approximately 15m from its junction with Sewardstone Road.

This Order will be incorporated into The Essex County Council (Epping Forest District) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) Consolidation Order 2019 by replacing tiles:

**Farm Hill Road, Waltham Abbey**

1. To Revoke the No Waiting Mon – Sat 8am to 6.30pm on Farm Hill Road, Waltham Abbey from its junction with Sewardstone road on both sides for approximately 50 metres and replace with No Waiting at Any Time.
2. To introduce a 23m Bus Stop Clearway cage on the north side of Farm Hill Road approximately 15m from its junction with Sewardstone Road.

To assist in promoting sustainable travel and use of public transport it is vital that bus services can operate as efficiently as possible. The introduction of No Waiting at Any Time restrictions is proposed to ensure buses have a clear route of travel as well as preventing parking near to a junction where parking is inappropriate.

Permanent Orders Section 1(1) of the 1984 Act states that local traffic authorities in England and Wales (outside London)<sup>2</sup> may make permanent orders for the following purposes relevant to this proposal:

- To avoid danger to persons or other traffic using the road or any other road or to prevent the likelihood of any such danger arising.
- To facilitate the passage on the road or any other road of any class of traffic (including pedestrians).
- To preserve or improve the amenities of the area through which the road runs.

**WHEREAS** Colchester City Council acting on behalf of the North Essex Parking Partnership in exercise of the delegated powers of the traffic authority Essex County Council granted under an Agreement dated 1<sup>st</sup> July 2022 in exercise of its powers under Sections 1(1), 2(1) to (3), 4(1), 4(2), 32, 35, 45, 46, 49 and 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. The Essex County Council (Epping Forest District) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) (Amendment No.51) Order 202x and shall come into operation on XX XX XX.
2. This Order will be incorporated into The Essex County Council (Epping Forest District) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) Consolidation Order 2019 ‘the 2019 Order’ by:
  - a. replacing the following Map Tiles:
    - TL385 005 revision 4 replacing with TL385 005 revision 5
    - TL385 002 revision 0 replacing with TL385 002 revision 1
    - TL380 002 revision 7 replacing with TL380 002 revision 8
    - TL380 005 revision 4 replacing with TL380 005 revision 5
3. The Map Schedule Legend to this Order only applies to the Map Tiles listed in this Order.
4. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restrictions or requirement imposed by regulations made or having effect as if made under the Act or by any other enactment.
